GOAL


mutual harmonization of spatial and economic requirements and others activities with landscape – ecological conditions of the land

- Slovak plant the key point toward the European market
- start March 2004 ... costs 1,1 milliards of dollars
- 300 000 cars / year
- European citizen is of the interest in 2004 import of 265 000 of cars
- year 2005 expectation increasing 425 000 cars

story of the owners

threat of soil expropriation – the actual theme – "construction of public interest

- when big international investors coming
- industrial parks
- freeways building

expropriation – association with the period of socialism interest of one private subject against another one according the law – compensation up to 70% project:

•270 ha

•12 000 owners

price of the parcels m²

•offer 96 crowns – expertise 360 crowns

the project started before parcels were buy up petitions

JUNE 2005, Zilina: The biggest cultural event in the region 3 days: music, dance, traditional handicraft

Company Kia Motors Slovakia as a "citizen" of Zilina and also the main sponzor.

Opening ceremony attended president of Slovakia, mayor of Zilina and president of the company.

Q: Can we negotiate with the soil owners?

America's River Communities, Inc.

Regional planning system for rural areas when lands and enterprises are under development pressure.

- Landowners financial windfall / shut out of this economic benefit
- **Developers** investment of time and money has no certain result
- Environmentalists to control sprawl have not worked
- Governmental officials believe that they cannot possibly satisfy all constituency groups

Inspiration: San Benito County Land Stewardship Program

Process of 5 steps:


- 1. Decide what the County should look like in the future.
- 2. Decide if the current system will achieve this vision.
- 3. Decide what is needed to fulfil this vision.
- 4. Evaluate the supply of lands with private rights, and the supply of lands with public value.
- 5. Match supply with demand.

Inspiration: San Benito County Land Stewardship Program

Benefits:

- Landowners all receive credits for the value of their land carrying out the County General Plan by protecting public value land
- Public process protects open space; it uses the market economy to keep that land out of development – forever
- **Developers** faster project approval with more certainty
- Governmental officials groups agree on a system for growth
